WHAT ARE WE LOOKING FOR?

POSTER PRESENTERS

Do you have a story to tell but you don't want to be a speaker? DIA welcomes abstracts for posters - an opportunity for you to present your work to a diverse international group of professionals. Presenting a poster will still give you the chance to share your experience with attendees during breaks, as well as the networking activity. Posters will be made available online to registered participants together with your pre-recorded presentation.

Maximum number of characters for posters abstracts (spaces included):

Abstract title | 125 | *Briefly describe the focus of the abstract as well as accurately reflect the content of the abstract.*

Keywords | 100 | *Please provide 1 or more keywords associated with your abstract. These may be used for search purposes should your abstract be selected as a concept.*

Learning Objectives | 300 | *Please provide a one-sentence statement of the objective of the abstract.*

Method | 300 | *When, where, and how was the study was done? What materials were used or who was included in the study?*

Results | 2000 | *What quantitative data was collected; what answer was found to the research question; what did the study find? Was the tested hypothesis true?*

Conclusion | 2000 | *State what can be concluded from the study and its implications.*

POSTER AWARDS

The conference will allocate time by the end of the event to announce **the best poster**. The winner will be awarded with a complimentary registration to the Clinical Trial Disclosure & Data Transparency Conference in 2021.
