 - Learning Objectives (Provide 2-3 learning objectives that clearly explain what participants should be able to do after attending this event within 400 characters including spaces.)
 - Full Description (Please provide complete details regarding your topic/presentation abstract within 2000 Characters including spaces.)
- Abstracts that describe just general information and common knowledge will not be accepted. Thus, new information, originality/uniqueness, and/or innovation should be included.
 - Abbreviations should be avoided
 - Submission of an abstract is understood to imply that the article is original and is not being considered for publication elsewhere

 - Conclusions (State what can be concluded from the study and its implications within 2000 characters including spaces.)
- Abstracts that describe just general information and common knowledge will not be accepted. Thus, new information, originality/uniqueness, and/or innovation should be included.
 - Abbreviations should be avoided
 - Submission of an abstract is understood to imply that the article is original and is not being considered for publication elsewhere

- Abstract must be typed in English
- Abstract must include the following contents
 - **The name of proposed topic/title** (125 characters including spaces)
 - **Keywords**; keyword limited to 100 characters
 - **Author's full name** (person making this proposal), degrees, institutions
 - **Objectives**: Benefit to the audience/DIA Japan Annual Meeting (Maximum 400 Characters including spaces)
 - **Overview**: 2-3 sentences summarizing your abstract. (Maximum 250 Characters including spaces)
 - **Full description**: Include following items (Maximum 2000 characters including spaces)
 - The name of proposed chairperson and presenters (If you can not come up with a name of the people you would like to propose as a chair or presenter, please fill out something like "I need support from program committee for speakers for the session.)
 - Methods (When, where, and how was the study was done? What materials were used or who was included in the study?)
 - Results (What quantitative data was collected; what answer was found to the research question; what did the study find? Was the tested hypothesis true?)
 - Conclusions (State what can be concluded from the study and its implications)
 - Session outline/format (e.g., 3 presentations (30 mins each: 90 mins in total); each presenter to provide lectures from different perspectives (academia, regulator and industry etc.) or 3 presentations (15 mins each) and panel discussion (45 mins) etc.)
- Abstracts that describe just general information and common knowledge will not be accepted. Please explain your idea in detail as much as you can (Abbreviations should be avoided)
